This certifies that _____ (recorded owner of mare at time of breeding) herein referred to as the Mare Owner, has engaged one breeding to Ninety Nine Goldmine for the 2010 breeding season for the following mare(s):

William & Donna Beierbach, owners of the above named stallion, will herein be referred to as breeder. This service is engaged subject to the following:

1. This contract is good for only one foal.
2. Stallion fees for the 2010 season are \$1000 Cdn. funds.
3. A non refundable booking fee of \$250 must be returned with this contract to ensure your mare will be added to stallion's roster. This will be subtracted from the stallions breeding fee. The balance of the stud fee is due when mare is pronounced safe in foal. The mare will not be released to the mare owner until stallion service fee, all veterinary expenses, board bills and other charges have been paid in full. No breeder's certificate will be issued until account has been paid in full. Please make cheques payable to Donna Beierbach.
4. Shipping/Collection fee will be \$250 (\$300 to U.S.A.) **First shipment is free.**
5. We will collect/ship at mare owner's request, excluding weekends. Please notify stallion owner no later than 10 a.m. of the day **prior** to needing a shipment.
6. Shipping container must be returned within 5 days of the date received. Mare owner will be charged a \$75 replacement fee.
7. Release/Hold Harmless: Breeder, Stallion Owner, its agents, employees, representatives, or guests, shall not be responsible for any disease, illness, theft, accident, loss, or death to the mare or foal. Mare Owner agrees to hold Breeder blameless if Mare fails to settle for any reason.
8. Live foal guarantee accompanies this contract. Live foal described as a foal that lives for one week after date of birth. Mare owner must provide a written notification from a licensed veterinarian of foal's death. This transaction is not transferable with the sale of mare without prior consent from breeder.
9. Third year rebreeds are subject to an additional booking fee, plus any increases in shipping charges. No live foal guarantee on third year rebreeds.
10. Should the above named stallion die, or become unfit for breeding, mare owner will receive the remaining \$750 portion of the breeding fee.
11. Should above mare die or become unfit for breeding a substitute mare will be accepted.
12. When mare owner, or authorized representative, signs and returns copy of this contract to Stallion owner, it will then be a binding contract on both parties subject to the above terms and conditions.
