William & Donna Beierbach, owners of the above named stallion, will herein be referred to as breeder. This service is engaged subject to the following:

1. This contract is good for only one foal.
  2. Stallion fees for the 2012 season are \$1500. **A non refundable booking fee of \$250 must be returned with this contract to ensure your mare will be added to stallion's roster.** This will be subtracted from the stallions breeding fee. The balance of the stud fee is due when mare is pronounced safe in foal. The mare will not be released to the mare owner until stallion service fee, all veterinary expenses, board bills and other charges have been paid in full. No breeder's certificate will be issued until account has been paid in full. **\*\*MARE CARE IS EXTRA\*\***
- \*\*\*# 3,4,5 Apply to shipped semen only\*\*\*
3. Shipping/Collection fee will be \$250 per shipment (\$300 to U.S.A.) First shipment is free. **For shipped semen customers all fees must be paid prior to first shipment being sent. (deposit, stud fee & any shipping charges)**
  4. We will collect/ship Monday, Wednesday, Friday. Please notify stallion owner as soon as possible of when you will be needing a shipment. Preferably the **day prior** to. **No semen orders will be processed after 8 a.m. C.S. T. on collection days.**
  5. EQUITAINER must be returned within 5 days of the date received. Mare owner will be charged a \$300 replacement fee. Disposable containers also available for use. Return fee is the responsibility of the mare owner.
  6. Release/Hold Harmless: Breeder, Stallion Owner, its agents, employees, representatives, or guests, shall not be responsible for any disease, illness, theft, accident, loss, or death to the mare or foal. Mare Owner agrees to hold Breeder blameless if Mare fails to settle for any reason.
  7. Live foal guarantee accompanies this contract. Live foal described as a foal that stands and nurses. Mare owner must provide a written notification from a licensed veterinarian of foal's death. This transaction is not transferable with the sale of mare without prior consent from breeder.
  8. Mare owner must administer appropriate vaccinations to the mare at various stages of her pregnancy, such as Pneumabort K. In the result of a lost pregnancy, if the mare owner does not provide adequate evidence that the vaccinations were administered, the stallion owner may refuse to honor the live foal guarantee.
  9. Third year rebreeds are subject to an additional booking fee, plus any increases in shipping charges. No live foal guarantee on third year rebreeds.
  10. Should the above named stallion die, or become unfit for breeding, mare owner will be refunded all fees except unpaid board bills, booking fees, and medical expenses incurred on behalf of the mare. **BOOKING FEES ARE NON-REFUNDABLE.**
  11. Should above mare die or become unfit for breeding a substitute mare will be accepted.
  12. When mare owner, or authorized representative, signs and returns copy of this contract to Stallion owner, it will then be a binding contract on both parties subject to the above terms and conditions.
  13. For all STALLION AUCTIONS an additional \$150 collection fee applies
